1. "AmQHA Australian members request the AusQHA to disclose their conflict of interest as an AmQHA Affiliate." The AusQHA cannot actively promote AmQHA membership, registration or programs as it is in direct conflict with AusQHA core business and detracts for AusQHA income streams.
